COURSE OUTLINE

- Day 1 starts with orientation and an introduction to the Stockmarket, including a brief lesson on its history and how it works. Next we move on to an explanation of global financial markets and an introduction to both fundamental and technical analysis. The discussion on technical analysis will then continue after lunch. The day will end with a lesson on risk management. We will also briefly discuss charting software and data.
- Day 2 will start with a quick explanation of the Active Investing strategy, followed by an interactive workshop. This first workshop will be based on the ActVest newsletter and the ActVest Trade Recorder. The next session will focus on short selling, once again using the Active Investing strategy. Finally we will look at the Active Trading strategy via the ActTrade newsletter. Active Trading is a short term version of Active Investing.
- Day 3 will start with a tutorial on break out trading and a workshop based on my new Break Out trading newsletter. And, as before, this workshop will employ the Trade Recorder as well. In the afternoon we'll delve into asset class shares; what their purpose is, how they differ from shares that are traded and how to identify & manage them.
- Day 4 will start with an explanation of the Active Fund Management strategy, including a practical demonstration on how to use the Blue Chip Report. This will be followed by Stuart McPhee talking on trading psychology for the next 2 sessions. The last session will be dedicated to Q&A.

TERMS AND CONDITIONS

- The total cost of the course is \$3,995 which includes 4 all-day sessions (fully catered) plus 12 month subscription to both the Blue Chip Report and the ActVest Newsletter. Also included is the ActVest Trade Recorder (Excel spreadsheet).
